 304th Civil Affairs Brigade, U.S. Army Reserves, based in Philadelphia, Pennsylvania.



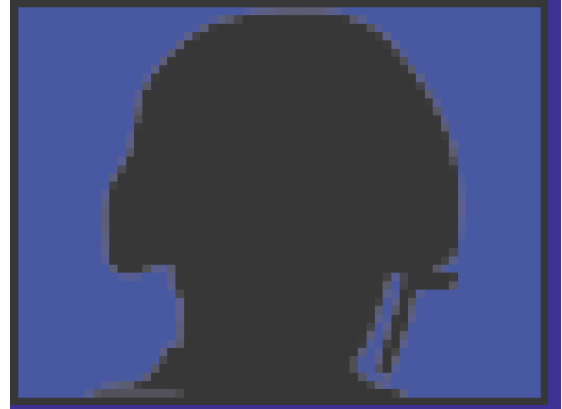
**08/27/03 Fusilier Russell Beeston 26 Govan, England**  
 Fatally wounded at Ali As Sharqi.  
 52<sup>nd</sup> Lowland Regiment attached 1<sup>st</sup> Battalion King's Own Scottish Border



**08/29/03 Staff Sergeant Mark A. Lawton 41 Hayden, Colorado**  
 Killed north of As Suaydat, Iraq. in a convoy that was hit by a rocket-propelled grenade.  
 244th Engineer Battalion, U.S. Army Reserve, Grand Junction, Colorado



**08/29/03 Sergeant 1st Class Mitchell A. Lane 34 Lompoc, California**  
 Died in Afghanistan conducting a fast rope infiltration into a known enemy cave complex.  
 Assigned to 2nd Battalion, 3rd Special Forces Group, Fort Bragg, North Carolina



**08/30/03 Sergeant Sean K. Cataudella 28 Tucson, Arizona**  
 Died in Ba'qubah, Iraq when his vehicle hit an embankment and rolled into a canal.

 Assigned to the 1st Battalion, 87th Infantry Regiment, 10th Mountain Division, Fort Drum, New York



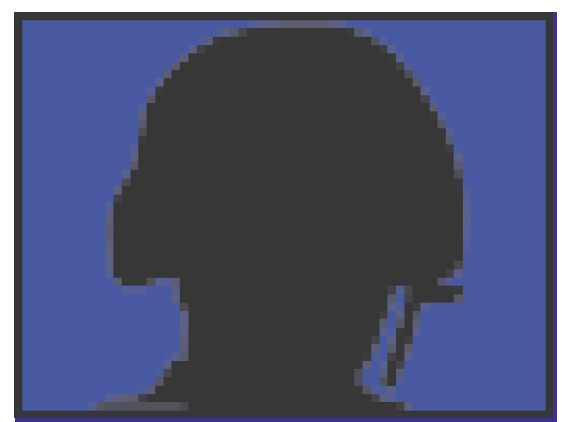
**08/31/03 Private First Class Adam L. Thomas 21 Palos Hills, Illinois**  
 Killed while on patrol, in Shkin, Afghanistan when his squad was attacked.  
 Assigned to the 1st Battalion, 87th Infantry Regiment, 10th Mountain Division, Fort Drum, New York  
 The incident is under investigation.



**09/01/03 Staff Sergeant Joseph Camara 40 New Bedford, Massachusetts**  
 Killed on Supply Route Tampa, south of Baghdad, Iraq when vehicle was struck by an I.E.D.  
 Assigned to the 115th Military Police Company, U.S. Army National Guard, Cranston, R.I



**09/01/03 Sergeant Charles T. Caldwell 38 North Providence, Rhode Island**  
 Killed on Supply Route Tampa, south of Baghdad, Iraq when his vehicle was struck by an improvised explosive device.  
 Assigned to the 115th Military Police Co., U.S. Army National Guard, Cranston, R.I.



**09/02/03 Private First Class Christopher A. Sisson 20 Oak Park, Illinois**  
 Died in Baghdad, Iraq in a UH-60 helicopter participating in an air assault mission.  
 Assigned to the 3rd Battalion, 325th Parachute Infantry Regiment, Fort Bragg, North Carolina



**09/01/03 Staff Sergeant Cameron B. Sarno 43 Waipahu, Hawaii**  
 Died in Kuwait City, Kuwait when hit by a truck while changing his vehicle's tire  
 Assigned to the 257th Transportation Company, U.S. Army Reserve, Las Vegas, Nev.



**09/07/03 Specialist Jarrett B. Thompson 27 Dover, Delaware**  
 Died at Walter Reed Army Medical Center in Washington, D.C. of vehicular injuries suffered on Aug. 30
