 Assigned to the Headquarters and Headquarters Battery, 17th Field Artillery Brigade, Fort Sill, Oklahoma



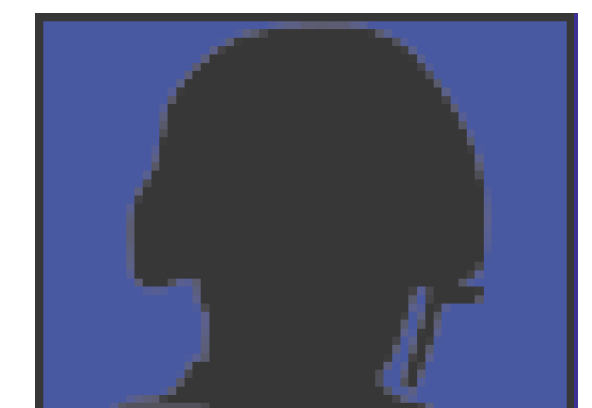
**10/01/03 Command Sergeant Major James D. Blankenbecler 40 Alexandria, Va.**

 Assigned to the Third Btn, Seventh Marine Reg., 29 Palms, California



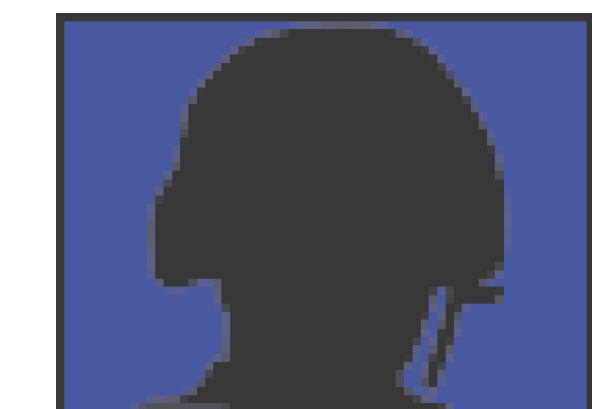
**10/03/03 Private First Class Charles M. Sims 18 Miami, Florida**

 Assigned to the 549th Military Police Company, Fort Stewart, Georgia



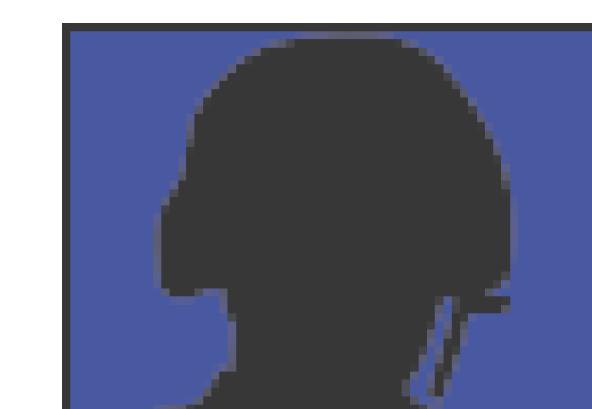
**10/03/03 Lieutenant Colonel Paul W. Kimbrough 44 Washington, D.C.**
