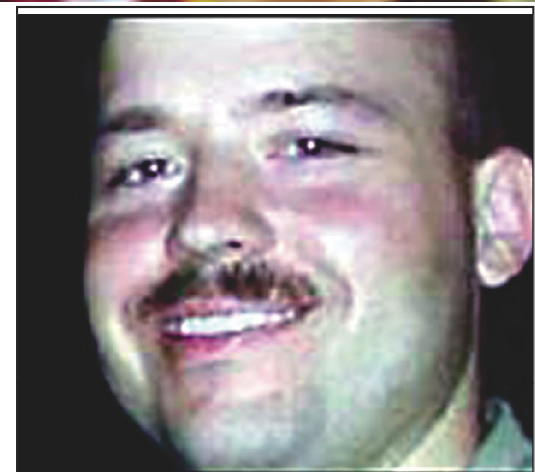

Killed in Baquba, Iraq, when his living area came under mortar attack.

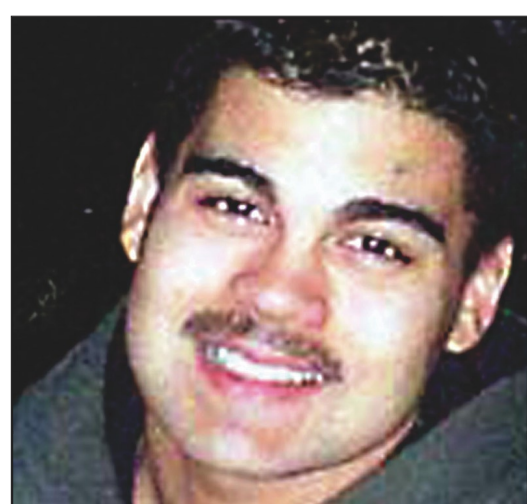
